1. Each booth will include 1 table and 2 chairs.
2. Each display will receive 110v electricity. Electricity required: YES/NO (Please Circle) \$25.00 additional charge.
3. Each exhibitor will receive 2 Exhibitor passes to the fair (Additional badges \$10.00 each).
4. Electrical cords must be taped to the floor.
5. Literature can be made available by the Exhibitor but NO LITERAURE MAY BE DISPERSED OUTSIDE THE AREA ALLOTTED TO THE EXHIBITOR.
6. Sirens, bells, amplifiers, flashing lights or any equipment causing annoyance is forbidden, unless agreed by the Contractor.
7. Exhibitor shall conform to all Federal, State and County laws and ordinances.
8. The display must be of professional quality.
9. Set-up and tear-down of the Exhibitor will be made during non-operating hours of Show.

IF THE ABOVE REGULATIONS ARE NOT OBSERVED, EXHIBITOR MAY BE REQUESTED TO VACATE HIS SPACE AND UNDER THESE CIRCUMTANCES, NO REFUNDS WILL BE GIVEN.
